### 5) Keep Drinking to Designated Areas!

a) Individuals drinking alcohol must do so within the designated Cluster Funk area and not outside on park grounds.

### 6) Carpool!

a) We have limited parking of about 200 spaces and the parking lot next to the amphitheater is reserved for loading equipment for artists and vendors.

b) There will be signs directing Cluster Funk attendees where to park.

### 7) No Unauthorized Vending!

a) All vendors must be pre-approved with a business license and vendor permit.

### 8) No Weapons Allowed!

a) Our security is here to make sure this all-ages event can be enjoyed by everyone with the utmost safety.

### 9) No Smoking, Underage Drinking or Drugs of any kind!

a) Polk County Conservation parks is a smoke-free environment. Smoking is prohibited in and around all facilities including open shelters.

b) Anyone found breaking these rules will be asked to leave with no refund and their wristband will be revoked.

### 10) No Littering!

a) Make sure to pick up after yourself and use designated trash cans. Leave no trace behind.

### 11) Have a Great Time!

a) We are here to have fun and socialize, so kick-back, relax, and enjoy the show!
